Enclosed, are the Report on the status of unfulfillment of the requests to the Republic of Croatia made by the refuged and expelled Serbs from the Republic of Croatia as well as other documents, that we would like to send, through You, to the officials and representatives of **the European Council, the European Commission and the European Parliament**. Those requests are contained in the Petition of Refuged and Expelled Serbs from the Republic of Croatia, which so far supported more than 60,000 citizens. The Report is probably the last attempt to regain our human, individual and property rights in Croatia.
